

**DEPOSIT REFUNDABLE 50,000 IN YOUR NAME TO GET  
RWA AND TO VERIFY ABOUT YOUR SBLC DIRECTLY  
FROM THE DEUTSCHE BANK ISSUING OFFICER**

**Before Paying Lease or Purchase fee payment,  
following is the Procedure to get verification of your  
applied for SBLC from the Bank Officer of the Issuing**

**Bank, Deutsche Bank, Frankfurt:**

- (A) Client shall remit the first installment of  
refundable 50,000 Euros for deposit in a European  
Bank Account, "MY EU PAY LTD." as given below.  
This Account is owned by the Frick Bank itself.  
This amount will remain in client's own name as  
Escrow Deposit in that Bank.**

- (B) Issuing Bank Officer of Deutsche Bank, Frankfurt will then send RWA,PRE-ADVICE of your required SBLC as Banker to Banker mail with his email address and phone No.
- (C) Your Receiving Bank officer can directly talk and verify about MT799 and MT760 of your applied for SBLC through Phone and/or email to the Deutsche Bank Issuing Officer. After your Banker phones to verify about your MT799 and MT760 to the Issuing Bank Officer, you can decide to proceed further or not. If not satisfied , you can instruct Frick Bank to send back your 50K deposit.

- (D) If satisfied, then deposit additional balance 450,000 in Frink Bank as 2<sup>nd</sup> installment and keep it in your name until you receive MT760. This deposit will remain in the lessee's name until Issuing Bank issues MT799 and MT760.**
- (E) After the receipt of MT760 and its verification, Lessee shall send an official letter to the Bank to transfer his 500,000 Euros Escrow deposit to the nominated bank account of the applicant (Provider), as this amount is regarded as Transmission Charges.**
- (F) Lessee can deduct his full Euro 500.000 refunded by deducting 500K from 1% commission of the Seller Mandate while paying 42+2 or 13+2 BG/SBLC cost.**
